

## ADVERTISEMENT FOR BIDS

Sealed proposals shall be addressed to and deposited with **Dale Crans, Supervisor of Maintenance and Facilities, Williamsport Area School District**, at **1400 West Third Street, Williamsport, PA 17701**, until 2:00 p.m., local prevailing time, **Monday March 25, 2019**, and at said time and place publicly opened and read aloud, for the following project:

Work generally consists of pavement repairs, milling and overlay, curb replacements, line painting, storm water improvements, retaining walls, and related work.

Each bid shall be accompanied by a certified check, a cashier's check or the bid bond of an approved Surety Company, in an amount of not less than **ten percent (10%)** of the amount of the proposal. Check or bond shall be drawn in favor of the **Williamsport Area School District**.

In compliance with Act #317 of 1978, approved November 26, 1978, and as amended November 23, 1982, no bidder may withdraw his bid for a period of sixty (60) days after the date set for the opening of bids, except if delayed by a required approval of another government agency, the sale of bonds, or the award of a grant or grants, in which case contract award would occur within 120 days of the date of bid opening, unless extended by mutual written consent of the contracting body and the bidder. Thirty (30) day extensions of the date for the award of the contract may be made by the mutual written consent of the Owner and the bidder.

Bidding Documents will be available **February 22, 2019** after 1:00 p.m. on the website. Interested parties are required to register on the website for the ability to view and/or acquire construction drawings and project manual for this project. Notice is given that the project for which construction bids are being solicited hereby is a project constituting public works and is subject to applicable provisions of the Pennsylvania Prevailing Wage Act, Act of August 15, 1961, P.L. 987, as amended and supplemented, and appropriate prevailing minimum wage rates as promulgated under provisions of said Act must be paid by contractors in connection with performance of necessary work.

Contractor shall and will be required to have the Act 34 State Police Criminal Record Check, Act 151 PA Child Abuse History Clearance, and also have an FBI Fingerprint Check in accordance with Act 114 for all prospective employees including subcontractors. All background checks and clearances shall be no more than one (1) year old.

There will be a mandatory pre-bid conference for this project on **March 12, 2019 at 1:00 p.m.** in the **Williamsport Area District Service Center Board Room** located at **2780 West Fourth Street, Williamsport, PA 17701**. Other contractor site visits are encouraged. Pre-bid site visits can be coordinated by contacting the Director of Maintenance and Facility Operations as noted above.

The Owner reserves the right to reject any or all bids, to waive any informality in the bidding, or to limit the scope of work involved. No bidder may withdraw a bid within sixty (60) days after the actual date of the opening thereof. Should there be reasons why the contract cannot be awarded within the specified period; the time may be extended by mutual agreement between the Owner and the Bidder

All work shall be completed and ready for use, on or before **August 19, 2019**.
