

SAFETY COMMITTEE MEETING

August 8, 2019

Call to Order: 10:00 a.m.

- I. Prior month's minutes were approved by a motion from Dale Crans.
- II. Group reviewed the Work Injury List.
- III. The safety newsletter from CM Regent this month discusses playground maintenance. A copy of this newsletter has been placed out on the district website.
- IV. Dale Crans informed the committee that Principal Brandon Pardoe has advised that the defibrillator will be returned to the swimming area at the High School at the start of the school year and will remain there until the end of the school year. Dale Crans will follow-up to make sure the defibrillator is returned to the swimming area.
- V. Dale Crans informed the committee that the Millionaire Café at the High School was cleaned by the custodial staff.
- VI. Rob Emerick mentioned that water should be delivered to the maintenance staff while they are working outside in the summer heat. Dale suggested to Rob that the maintenance staff take the large yellow coolers with them on their trucks and fill them with water and ice from the school cafeteria at the building they are assigned for drinking purposes.
- VII. Dale mentioned that the Board of Directors approved the removal of 5 trees and the trimming of 42 trees at Cochran by a contractor.
- VIII. Kurt Kunze advised the committee that the building inspections for the 2019-2020 school year will begin on Monday, August 12, 2019 at 8:00 a.m. Dale Crans, Staci Godfrey, and Kurt Kunze will be inspecting Curtin, Cochran, Stevens, and Jackson schools. - IX. Kurt Kunze advised the committee that Patti Webster and Staci Godfrey volunteered to do the building inspections at Hepburn Lycoming and

Lycoming Valley schools on Tuesday, August 13, 2019 at 8:00 a.m. Rob Emerick also volunteered to assist with the inspections. Dale Crans stated that he will schedule Rob Emerick to work in that area so he may assist.

- X. Dale Crans mentioned that the Millionaire Drive project is on schedule.
- XI. Dale Crans advised the committee that humidity sensors have been installed in every building on every floor to monitor the humidity, to prevent mold in the buildings.
