

## INVITATION TO BID

Williamsport Area School District (Owner) will be accepting quotations for construction services for the Lycoming Valley Culvert Replacement Project. Proposals shall be received in a sealed envelope entitled "Lycoming Valley Culvert Replacement Project" addressed to and deposited with Wanda Erb, Business Administrator, Williamsport Area School District, at the Business Office in the District Service Center located at 2780 West Fourth Street, Williamsport, PA 17701 by 2:00 pm on July 9, 2021. At 2:00 pm on the same day at the Business Office in the District Service Center located at 2780 West Fourth Street, Williamsport, PA 17701, Bids will be publicly opened and read aloud for the following project:

### **PROPOSAL – LYCOMING VALLEY CULVERT REPLACEMENT**

The project will generally consist of the replacement of the culvert, end treatments, and associated pavement restoration located at the driveway entrance to the Lycoming Valley Intermediate School located at 1825 Hays Lane, Williamsport, PA 17701.

Notice is given that the project for which construction bids are being solicited hereby is a project constituting public works and is subject to applicable provisions of the Pennsylvania Prevailing Wage Act, Act of August 15, 1961, P.L. 987, as amended and supplemented, and appropriate prevailing minimum wage rates as promulgated under provisions of said Act must be paid by contractors in connection with performance of necessary work.

Contractor will be required to have the Act 34 State Police Criminal Record Check, Act 151 PA Child Abuse History Clearance, and also have an FBI Fingerprint Check in accordance with Act 114 for all prospective employees including subcontractors. All background checks and clearances shall be no more than one (1) year old.

Bidders will be required to provide Bid security in the form of a Bid Bond or certified check in an amount no less than 10 percent of the Bid Sum.

The Owner reserves the right to accept or reject any or all Bids. Bids will be required to be submitted under a condition of irrevocability for a period of 60 days after submission. No Bidder may withdraw his Bid before the expiration of the 60 day period.

All work shall be substantially complete on or before **August 9, 2021**.
